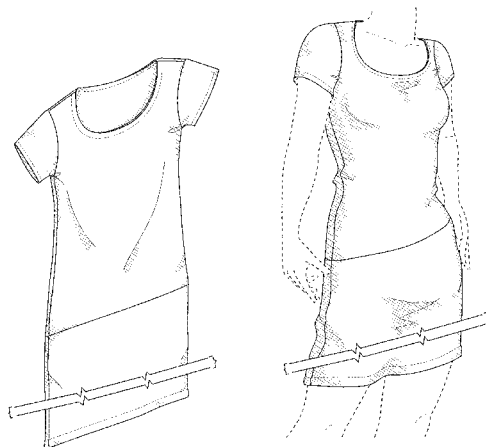
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the dress showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a back view thereof;
 FIG. 4 is left view thereof;
 FIG. 5 is a right view thereof;
 FIG. 6 is the top view thereof;
 FIG. 7 is the bottom view thereof; and,
 FIG. 8 is an environmental view of a wearer wearing the dress of FIG. 1.
 In FIGS. 1-5 and 8, the broken away portions show no specific length.
 The broken lines depict portions of the dress and the human that form no part of the claimed design.

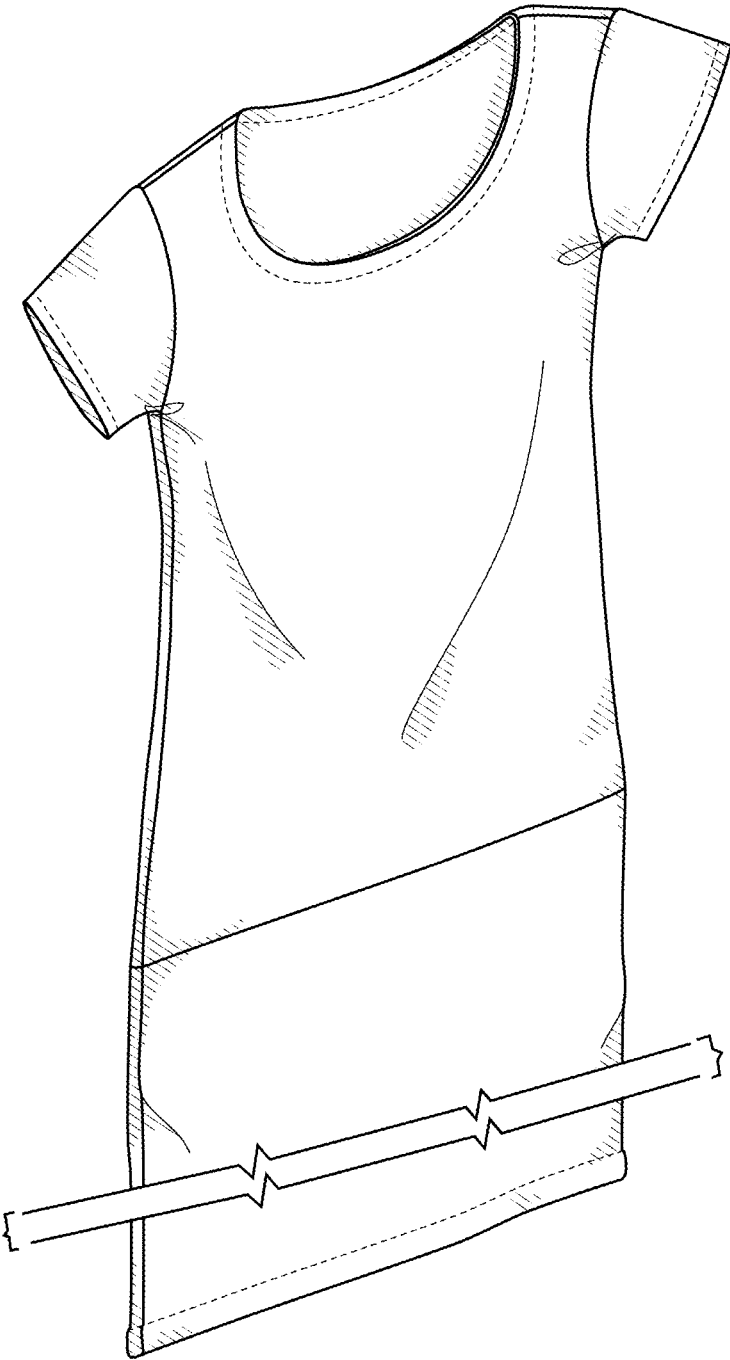

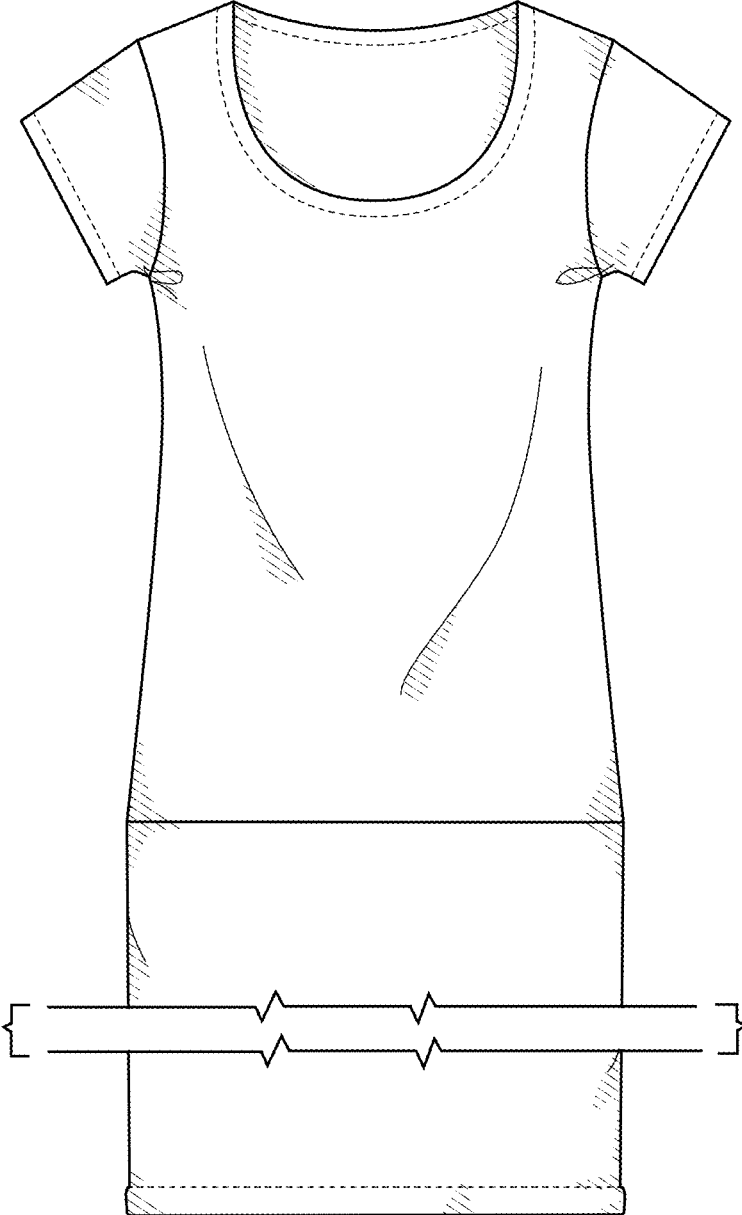

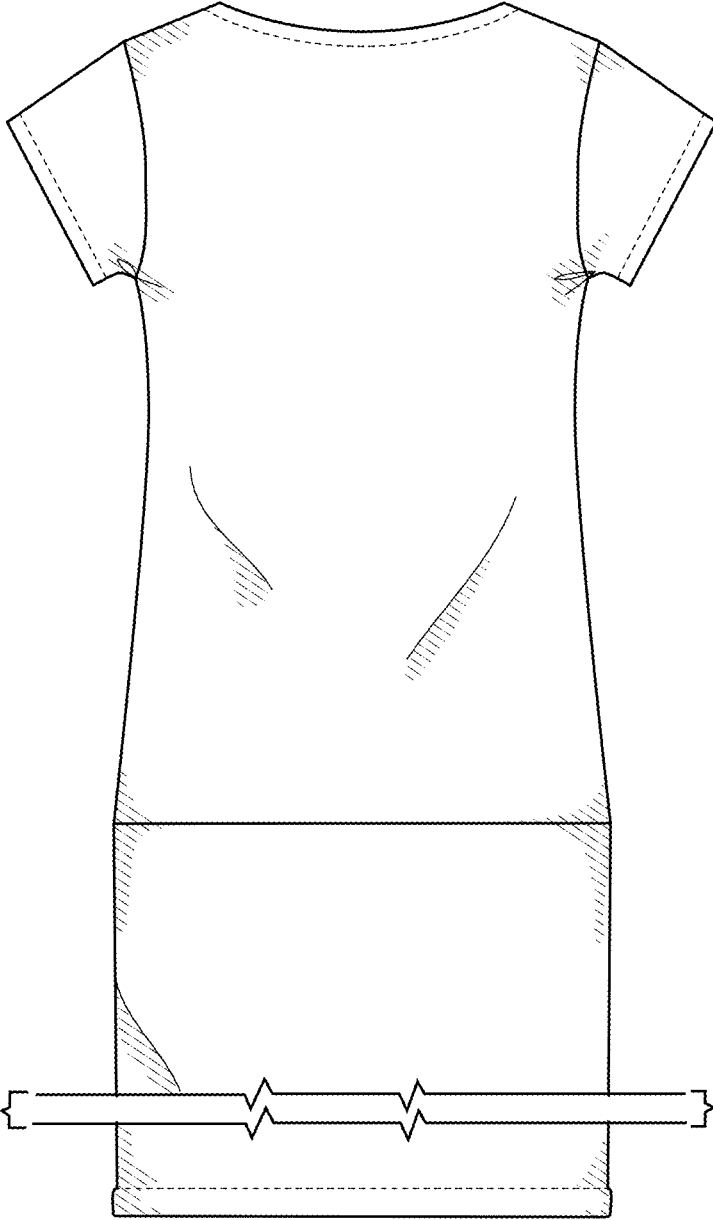

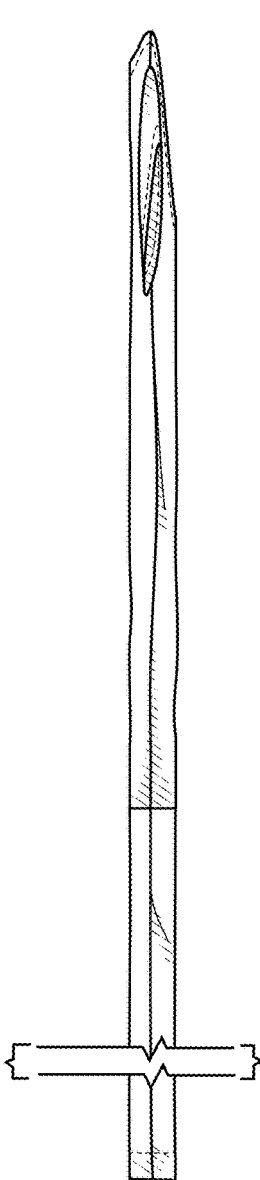

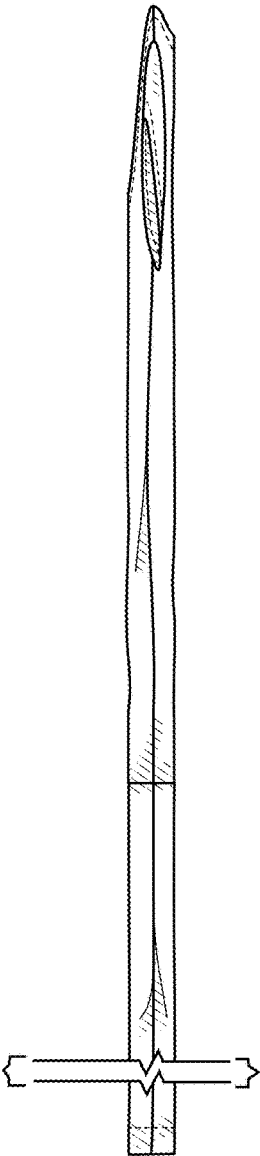

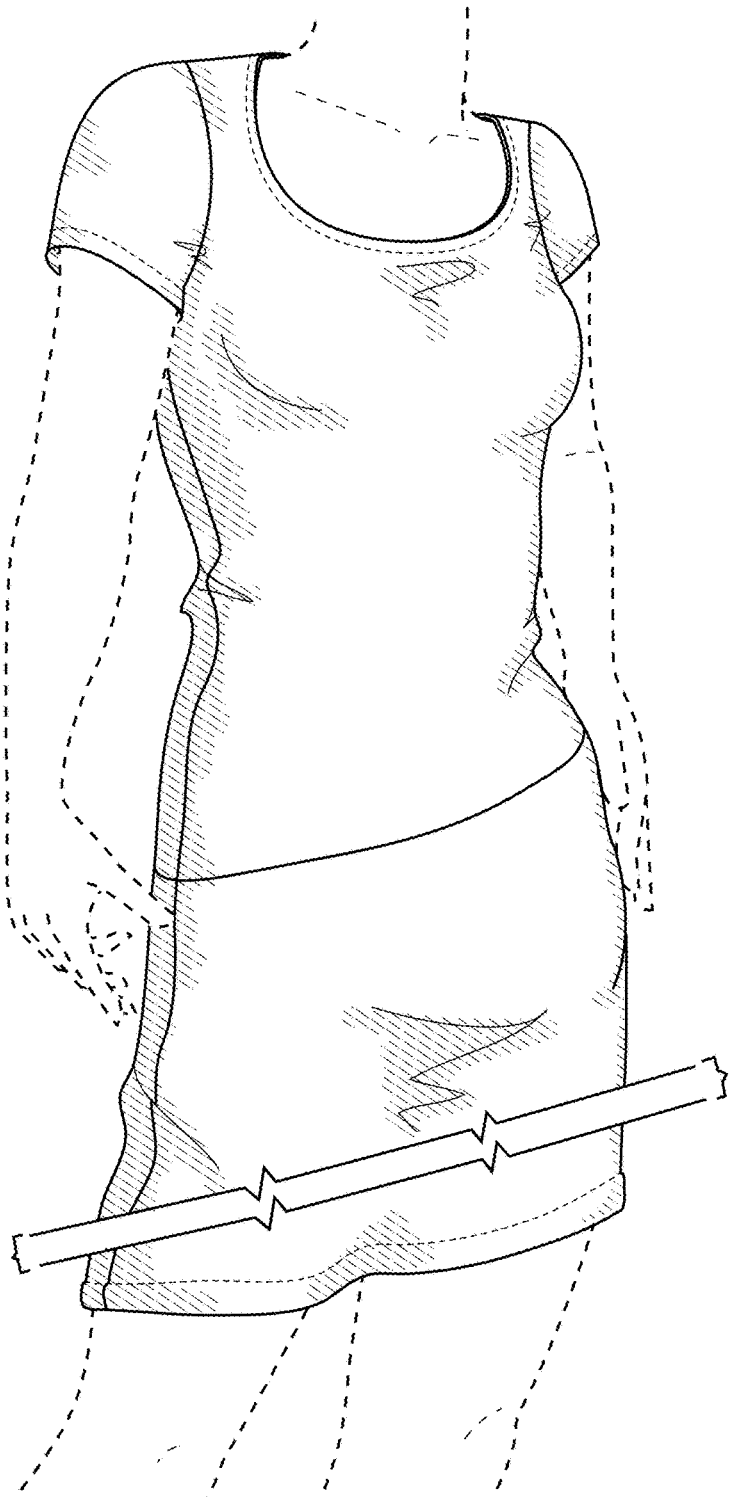
