FIG. 3 is a bottom view of the bow of FIG. 1.

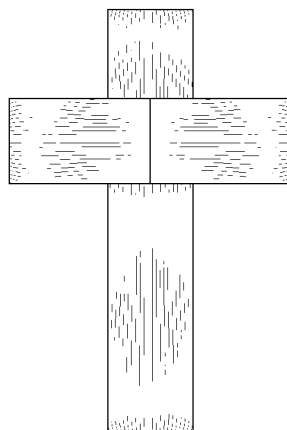
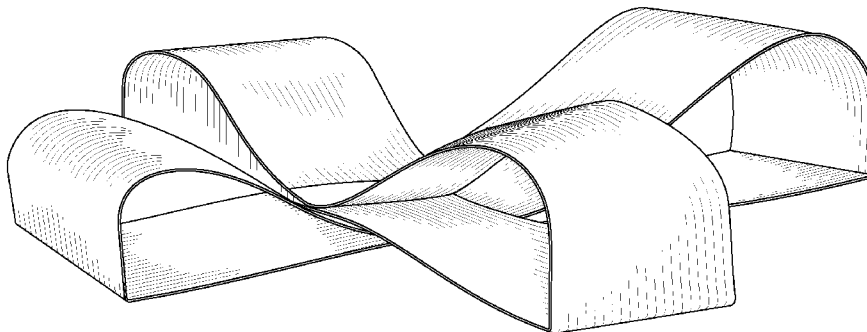
FIG. 4 is a left side plan view of the gift bow of FIG. 1

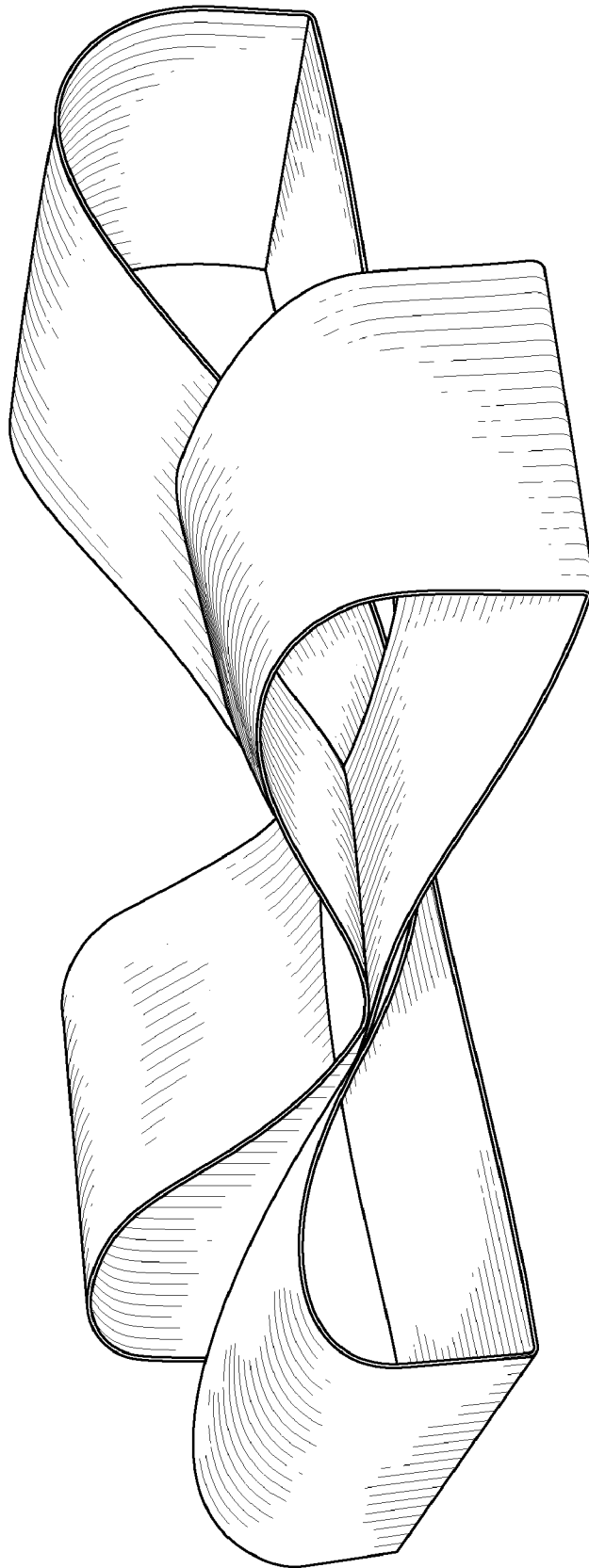

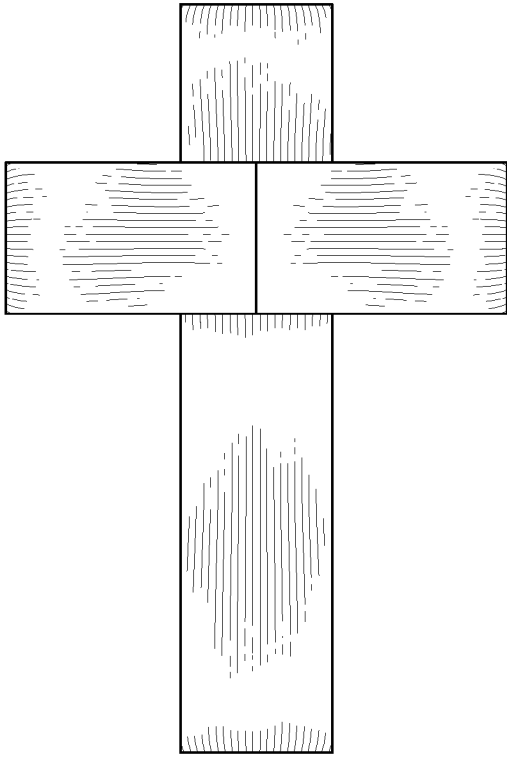

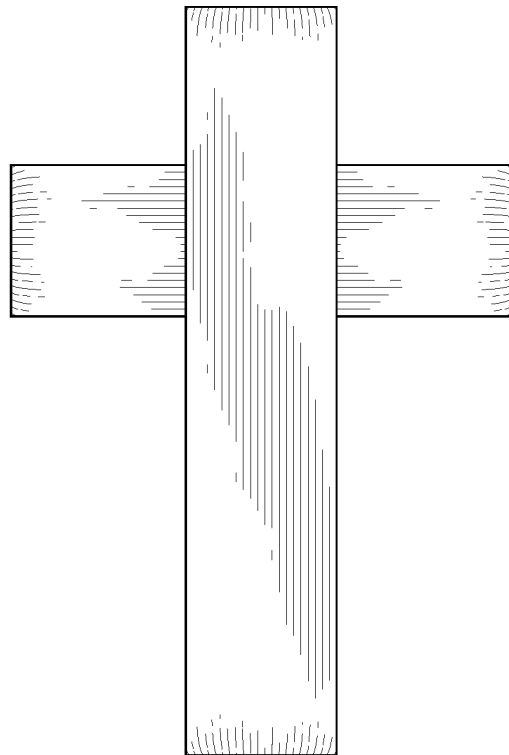

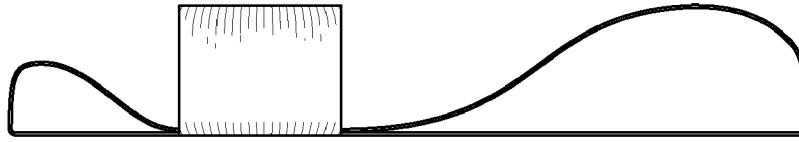

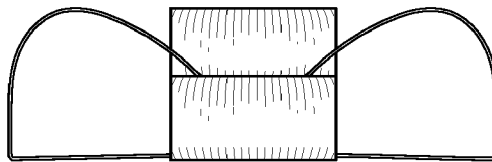

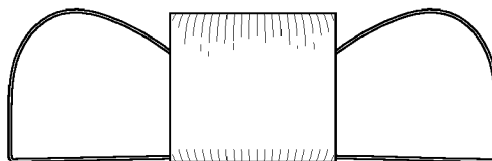
