FIG. 6 is a top plan view of the invention;

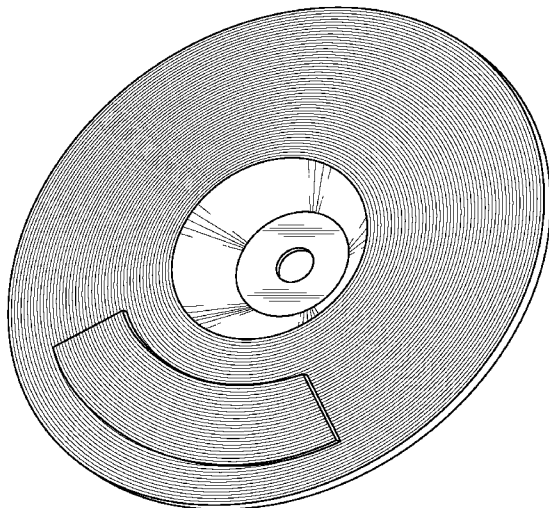
FIG. 7 is a bottom plan view of the invention;

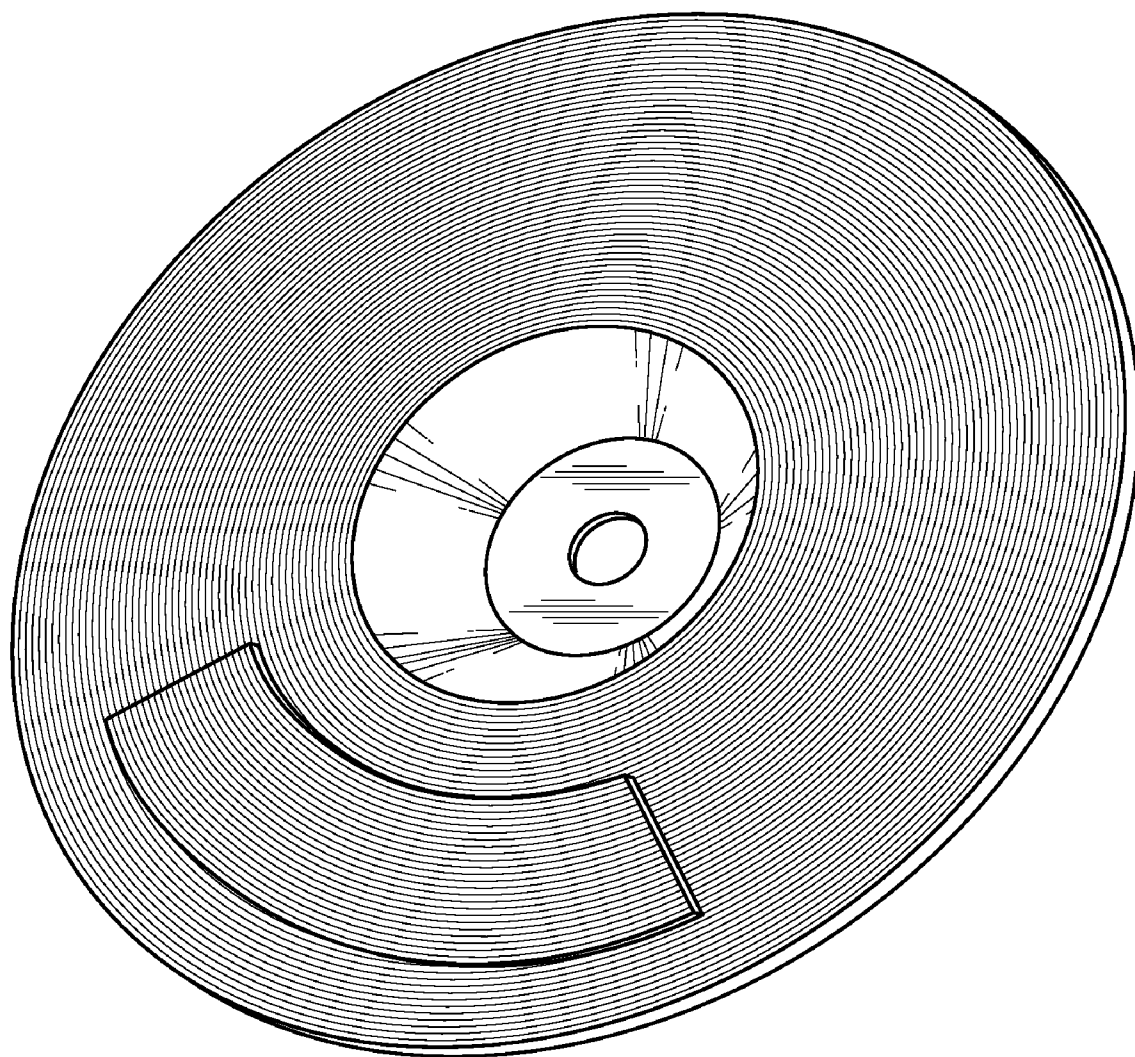

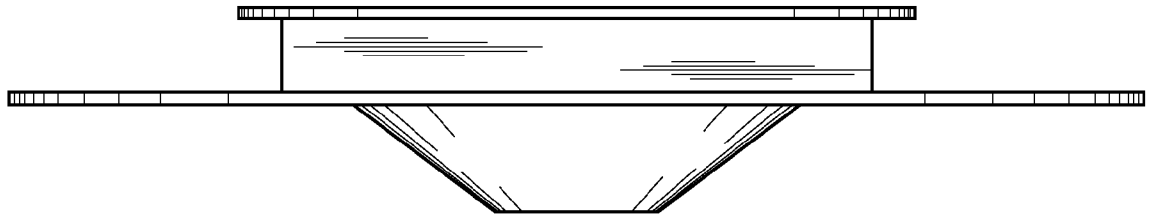

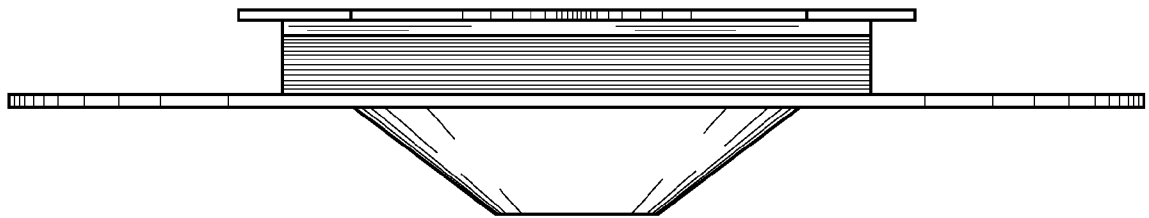

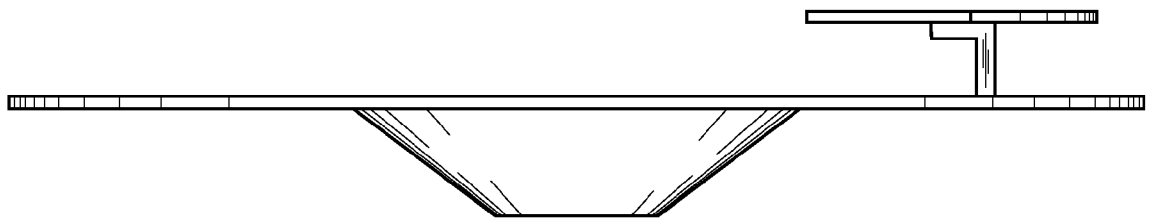

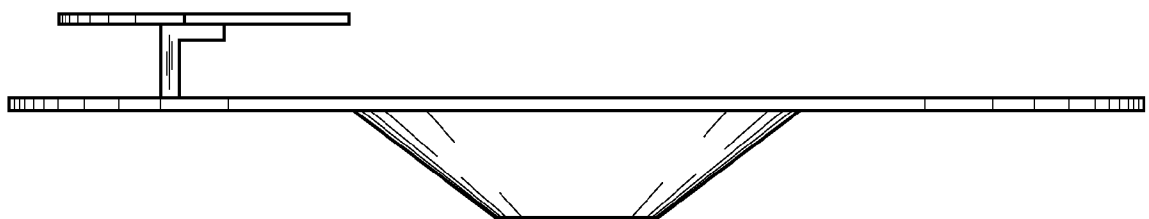

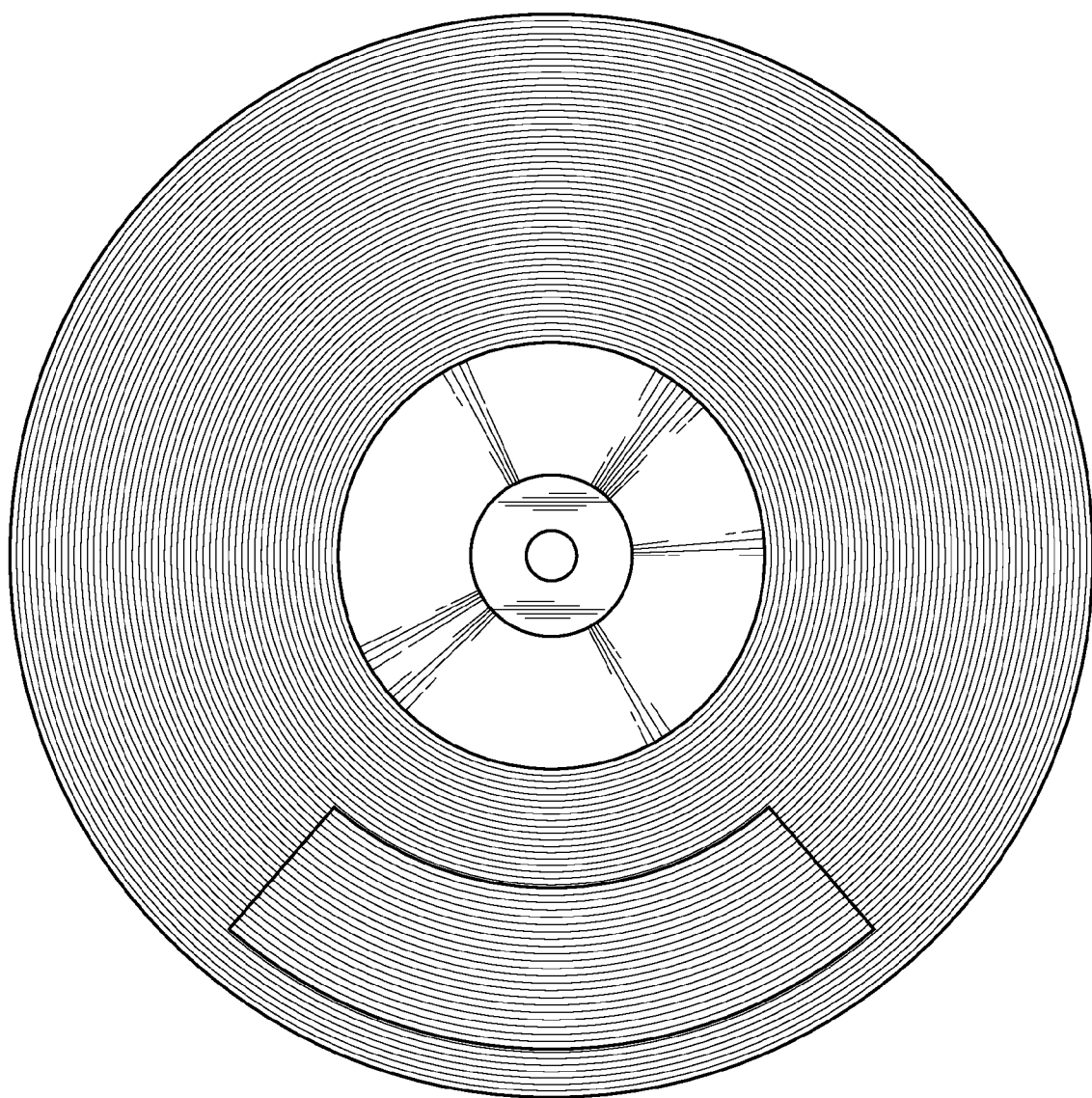

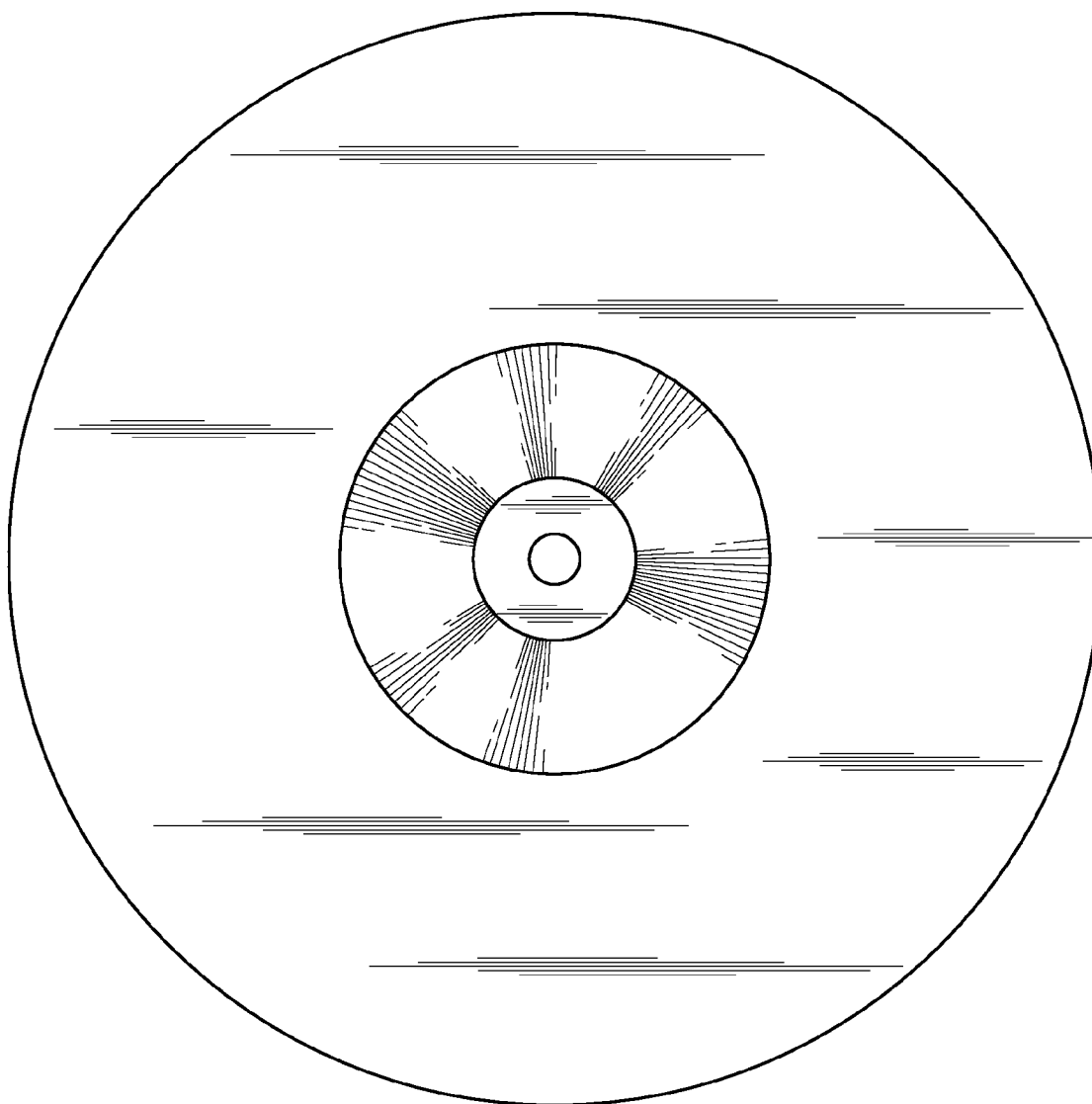

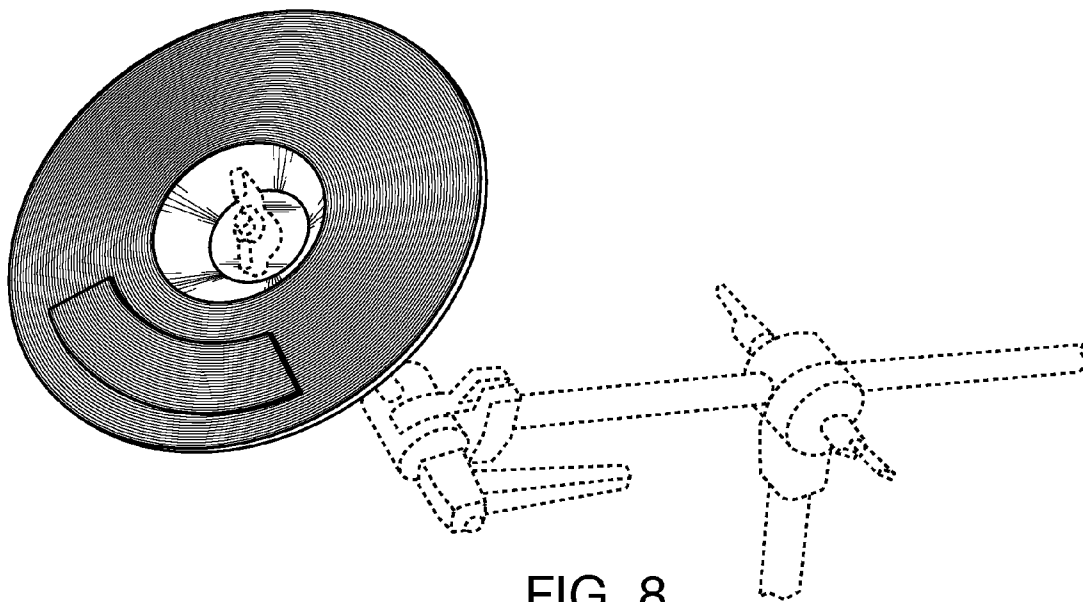

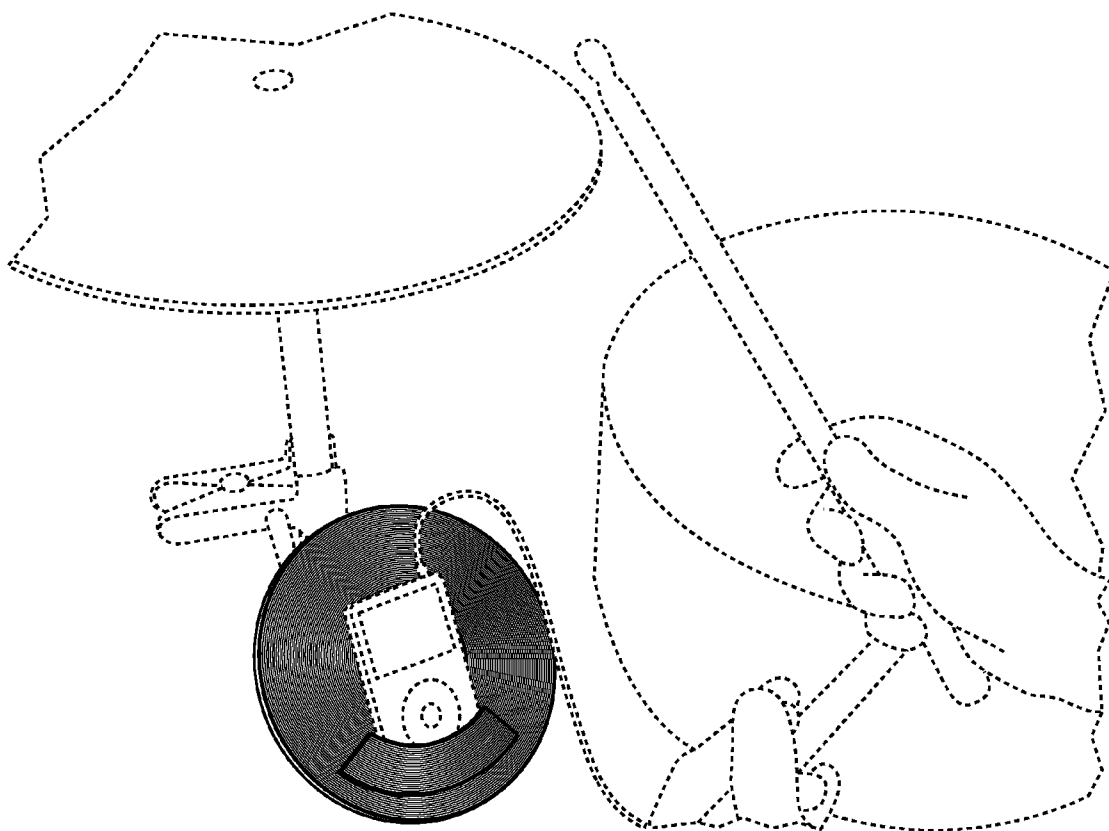
