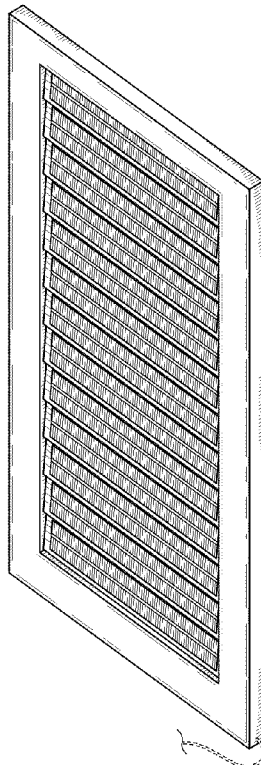
(57) **CLAIM**

The ornamental design for a shutter with solar cell lamellae, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shutter with solar cell lamellae.
 FIG. 2 is a front elevation view of the shutter with solar cell lamellae of FIG. 1.
 FIG. 3 is a back elevation view of the shutter with solar cell lamellae of FIG. 1.
 FIG. 4 is a top plan view of the shutter with solar cell lamellae of FIG. 1.
 FIG. 5 is a bottom plan view of the shutter with solar cell lamellae of FIG. 1.
 FIG. 6 is a right side elevation view of the shutter with solar cell lamellae of FIG. 1; and,

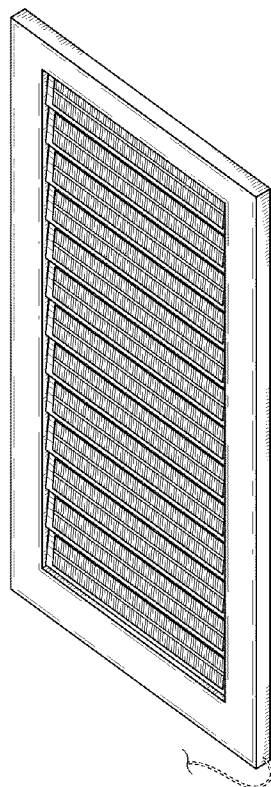

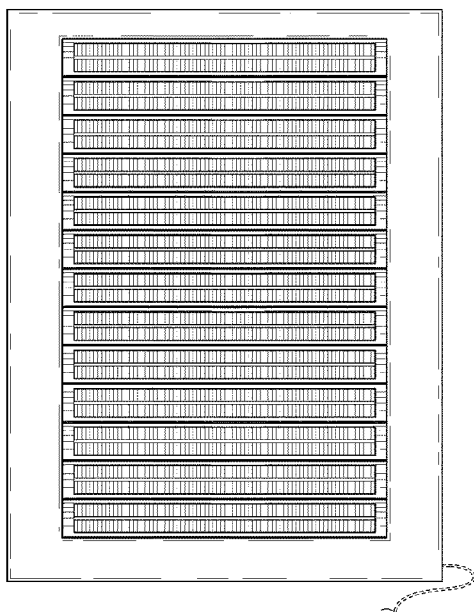

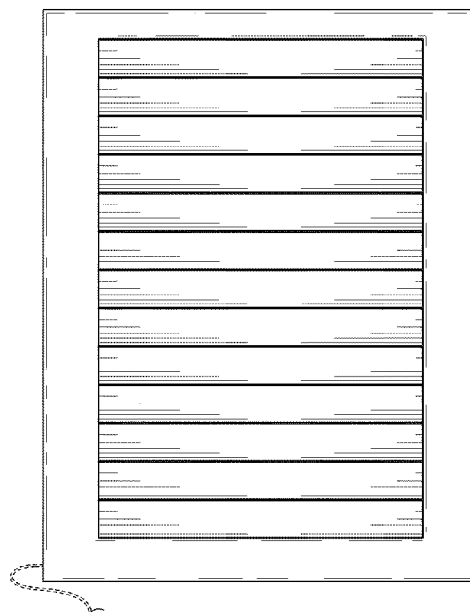

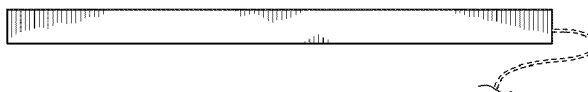

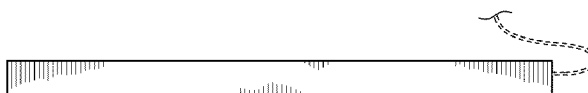

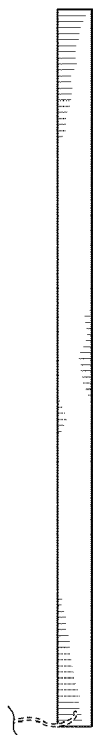
